

SETTING START & RUN INTERVALS EXAMPLES

TO SET RUN TIME FOR 42 SECONDS DIAL 1; 0.1 SECOND - 10 HOURS DIAL 2; MULTIPLES OF 1 - 10 ADJUST DIAL 1 = 6S, ADJUST DIAL 2 = 7, TOTAL RUN TIME = 6S X 7=42 SECONDS

TO SET OFF TIME FOR 2 HOURS DIAL 3; 0.1 SECOND - 10 HOURS DIAL 4; MULTIPLES OF 1 - 10 ADJUST DIAL 3 = 1H, ADJUST DIAL 4 = 2, TOTAL TIME OFF = 1H X 2=2 HOURS



FITTING THE ODOUR DOSE TO YOUR PUMP

THE OZMIST ODOUR DOSE MODULE IS DESIGNED TO BE INTEGRATED EASILY INTO ANY HIGH PRESSURE MISTING SYSTEM.

THE ODOUR DOSE MODULE IS CONNECTED TO THE WATER SUPPLY (GARDEN TAP) AND THE BLUE HOSE IS CONNECTED TO THE HIGH-PRESSURE PUMP INLET AT THE FILTER HOUSING.

THE ODOUR DOSE MODULE IS SUPPLIED WITH A SNAP-ON GARDEN HOSE FITTING AS DEFAULT, BUT WE WOULD RECOMMEND PLUMBING THE MODULE IN PERMANENTLY WHERE POSSIBLE.

AT THE END OF THE BLUE HOSE THERE IS A BRASS HOSE BARB AND CLAMP SUPPLIED TO CONNECT DIRECTLY TO THE OZMIST HIGH-PRESSURE PUMP MODULE VIA THE FILTER. (YOU MAY NEED TO REMOVE THE EXISTING FITTING TO ALLOW FOR THE HOSE BARB TO SCREW IN)

THE ODOUR DOSE MODULE MUST BE POSITIONED IN AN UPRIGHT POSITION TO MAINTAIN THE CORRECT ORIENTATION OF THE COMPONENTS INSIDE THE CABINET.

THE ODOUR DOSE MODULE REQUIRES A 240V POWER SUPPLY FOR OPERATION, THIS CAN BE ACHIEVED IN TWO WAYS.

- IF YOU PURCHASED THE ODOUR DOSE MODULE AT THE SAME TIME AS YOUR HIGH PRESSURE PUMP, OZMIST WOULD NORMALLY FIT A SPECIAL POWER PLUG TO THE PUMP MODULE CABINET AND LEAD COMING FROM THE ODOUR DOSE MODULE. IN THIS EXAMPLE THE HIGH PRESSURE PUMP MODULE SUPPLIES POWER TO THE ODOUR DOSE MODULE WHEN THE SELECTOR SWITCH IS IN THE ON POSITION. THE ODOUR DOSE MODULE STARTS AS SOON AS THE HIGH PRESSURE PUMP MODULE IS TURNED ON AND WILL OPERATE AT THE SET TIME INTERVALS UNTIL POWER TO THE HIGH PRESSURE PUMP IS TURNED OFF. IF YOU WANT MIST BUT NO ODOUR, TURN THE ODOUR DOSE SWITCH TO THE OFF POSITION.

- IF YOU PURCHASED THE ODOUR DOSE MODULE SEPERATELY WE FIT A 3 PIN PLUG TO THE LEAD FROM THE ODOUR DOSE MODULE WHICH YOU WILL PLUG INTO A WALL SOCKET NEXT TO THE PUMP. WHEN YOU TURN THE MIST PUMP ON YOU WILL ALSO NEED TO TURN ON THE ODOUR DOSE MODULE EITHER AT THE POWER SUPPLY AND / OR THE ON SWITCH ON THE ODOUR DOSE MODULE.

THE ODOUR DOSE STARTS ITS FIRST RUN CYCLE WHEN THE PUMP STARTS. AFTER THE INITIAL RUN TIME IT WILL REST UNTIL THE REST TIME HAS EXPIRED.

DONT FORGET TO BLEED THE SYSTEM OF AIR WHEN FIRST TURNED ON

THE ODOUR DOSE MODULE HAS 3 MAIN COMPONENTS LOCATED INSIDE THE CABINET.

- CHEMICAL CONTAINER
- DOSING PUMP
- DUAL RUN / REST TIMERS

WHEN YOU HAVE YOUR ODOUR DOSE MODULE IN POSITION AND CONNECTED TO YOUR HIGH PRESSURE PUMP MODULE YOU WILL BE ABLE TO SET THE CONTROL PARAMETERS AND GET THE MODULE OPERATIONAL.

• -FIRST STEP-IS TO FILL THE CONTAINER WITH YOUR DESIRED CHEMICAL.

• -SECOND STEP-

YOU WILL NEED TO SET YOUR PARAMETERS ON THE DOSING PUMP. THE CONTROLS ARE SIMPLE, THE LARGE YELLOW DIAL WILL SET THE STROKE LENGTH OF THE CYCLE. PRESSING THE MODE BUTTON WILL ALLOW YOU TO CHANGE THE LITRES PER MINUTE AND STROKE RATE. (FURTHER INSTRUCTIONS ON NEXT PAGE).

-THIRD STEP-

NOW YOU CAN ADJUST THE ON AND OFF CYCLES FOR THE ODOUR DOSE UNIT, THIS IS ACHIEVED BY ADJUSTING THE SMALL DIALS ON THE GREY BOX AT THE TOP OF THE MODULE. THERE ARE FOUR DIALS THAT NEED TO BE ADJUSTED, THE TOP TWO DIALS ARE THE RUN CYCLE AND THE BOTTOM TWO DIALS ARE THE REST CYCLE.

YOU NEED TO SET ALL DIALS FOR THE RUN TIME AND REST TIME. TO SET ON TIME DIAL 1; INCREMENTS FROM 0.1 SECOND TO 10 HOURS DIAL 2; MULTIPLES OF 1 TO 10 IF YOU WANT TO RUN FOR 42 SECONDS DIAL 1 = 6S DIAL 2 = 10 6 X 7 = 42 SEC TO SET OFF TIME FOR 2 HOURS DIAL 3; 0.1 SECOND - 10 HOURS DIAL 4; MULTIPLES OF 1 - 10 DIAL 3 = 1H, DIAL 4 = 2, 1H X 2=2 HOURS • -FOURTH STEP-

TURN ON THE WATER & ODOUR DOSE UNIT.

PLEASE NOTE THAT YOU WILL HAVE TO BLEED AIR FROM THE DOSING PUMP SUCTION LINE ON THE FIRST START UP, THIS CAN BE ACHIEVED BY OPENING THE VALVE AT THE REAR OF THE DOSING PUMP. TURN ON THE HIGH PRESSURE PUMP AND ODOUR DOSE MODULE. YOU WILL HEAR THE DOSING PUMP START UP AND SEE LIQUID BEING DRAWN UP THROUGH THE CLEAR HOSE BETWEEN THE CHEMICAL TANK TANK DOSING PUMP. WHEN THE AIR IS CLEAR, TIGHTEN THE VALVE AT THE REAR OF THE DOSING PUMP.



SETTING THE DOSAGE RATE

THE ODOUR DOSE MODULE IS CAPABLE OF INJECTING UP TO 100ML OF CHEMICAL INTO THE MIST PUMP WATER SUPPLY PER MINUTE. IT IS IMPORTANT TO INTRODUCE THE MINIMUM AMOUNT OF CHEMICAL AS IS REQUIRED AS CHEMICALS CAN BE EXPENSIVE AND SOMETIMES OVER POWERING. IF YOUR CONSULTANT HAS PROVIDED A MIXING RATIO YOU WILL ALSO NEED TO KNOW THE AMOUNT OF WATER RUNNING THROUGH THE MIST SYSTEM PER MINUTE. THIS CAN BE CALCULATED BY COUNTING THE NOZZLES IN THE SYSTEM AND DETERMINING THEIR SIZE. A NUMBER IS STAMPED ON THE FRONT OF EACH OZMIST NOZZLE. NOZZLE FLOW RATES ARE SHOWN BELOW; .13MM = 0.036 L/PM .3MM = 0.11 L/PM .5MM = 0.308 L/PM TO DETERMINE THE FLOW RATE PER MINUTE MULTIPLY THE NUMBER OF NOZZLES IN THE SYSTEM BY THE FLOW RATE FOR THE NOZZLES FITTED = TOTAL FLOW RATE PER MINUTE.

ADVANCED DOSING PUMP INSTRUCTIONS ARE IN THE PRINTED BOOKLET INSIDE THE CABINET. AS AN EASY START UP WE RECOMMEND SETTING THE STROKE RATE TO 100%. SET THE OUTPUT TO % BY SIMULTANEOUSLY PUSHING THE UP AND DOWN ARROWS TOGETHER. IN THE PERCENTAGE MODE YOU CAN THEN SET THE PERCENTAGE OF THE MAXIMUM OUTPUT IE; THE MAXIMUM OUTPUT IS 100ML/MIN IF YOU NEED ONLY 50ML/PM THEN ADJUST THE PERCENTAGE TO 50% OF THE MAXIMUM.

IF WITHIN THE WARRANTY PERIOD DEFINED BELOW, YOU BELIEVE A PRODUCT YOU HAVE PURCHASED FROM US DOES NOT COMPLY WITH THIS WARRANTY, THEN YOU MUST FOLLOW THE PROCESS SET OUT IN THIS WARRANTY DOCUMENT.

1. AUSTRALIAN CONSUMER LAW DISCLAIMER

OUR GOODS AND SERVICES COME WITH GUARANTEES THAT CANNOT BE EXCLUDED UNDER THE AUSTRALIAN CONSUMER LAW. 2. FURTHER INSPECTION

IF WE DETERMINE THAT YOUR PRODUCT MAY BE DEFECTIVE, WE WILL EITHER;
